10 gives notice to the Court, the Special Master and the Parties that the Unitary Status Plan
11 Budget, attached hereto as Exhibit A, was adopted by the District’s Governing Board at its
12 meeting on May 7, 2013. The Special Master’s recommendations, submitted in accordance
13 with Section X(B)(4) of the USP, are attached hereto as Exhibit B. Attached as Exhibit C is
